



## Contractual Agreement for Wedding Videography

A \$400 non-refundable deposit is required to reserve your wedding date. The amount will go toward the balance of your video and insures the booking of your wedding. The remainder of the balance along with an 8.25% sales tax will be due 2 weeks prior to the wedding date. You can mail checks to 41 Productions, 6900 I-40 West Suite #160, Amarillo, TX 79106.

In the event that something happens out of the Videographer's control (camera and/or computer and editing software malfunction, scratched tape, power outage, illness or accident, etc...) no legal action can be taken against 41 Productions. You will receive a full refund minus the \$400 deposit and if applicable, any raw footage shot.

If weather permits, the Videographer will not be able to shoot due to the safety of the equipment and/or employees. You take that risk and will not receive a refund. We will do everything possible to attend, but we will not jeopardize the safety of our employees. We will make a conscious decision whether or not to drive and/or shoot in bad weather.

If the wedding gets cancelled for any reason whatsoever, you will not receive a refund and you will be responsible for paying half of the remaining balance.

It is your responsibility to secure permission for 41 Productions to shoot the wedding in your desired location. In the event that shooting is not permitted, you will not receive a refund. We can not guarantee unobstructed shots due to the set-up of your location or limited mobility.

Our primary goal is your satisfaction. Please understand that 41 Productions will produce your video to the best of our ability. Know that it is a creative piece of work and refunds will not be given due to your opinions of the video, but ONLY if the criteria of your package was NOT fully produced. If there is controversy about the final video, 41 Productions is limited to refund the \$400 deposit.

Your video will be copyrighted by 41 Productions and any duplications or copies made are prohibited unless authorized by the company.

41 Productions does not guarantee specific people or events will be shot or included in your video, but we will do our best to capture as much as possible.

No two wedding videos will be exactly the same, therefore, the length of each video will vary.

Portions of your wedding footage could potentially be used for promotional or website use.

Unless otherwise noted, you will receive your video 4-6 weeks after your wedding date or 4-6 weeks after your final payment, whichever comes last. You have 30 days to contact us if any problems should arise regarding the DVDs.
